- Over **300** early care and education programs have received direct support to improve quality, expand services, or build more inclusive environments.

And still, the need is growing. A recent Milestones' survey shows that **1 in 3 licensed child care providers** in Colorado may close without continued investment. Families with young children continue to navigate health care gaps, affordability barriers, food insecurity, and workforce disruptions. Thriving families are the foundation of our economy and community well-being.
